District Superintendent Order No. 915-22-001

Angeles District – Bicycle Types and Use

Whereas:

Bicycle use in the Angeles District is an extremely popular form of outdoor recreational activity, and now Electric Bicycles (E-Bikes) are exploding in popularity. E-Bikes offer riders increased park accessibility and rider assistance, but the devices must be safe and compatible with the park visitor experience, and they must minimize resource impact.

Therefore:

1. To determine the viability of E-Bikes in the Angeles District; Class 1 E-Bikes will temporarily be allowed for demonstration purposes necessary to improve knowledge and understanding of potential issues related to E-Bike use.
2. E-Bikes will be allowed on trails and roads already designated for traditional (non-electric) bicycles.
3. E-Bikes will create new opportunities for recreation and visitor access within the parks, and provide additional benefits, including improved recreational opportunities for all visitors including those with physical challenges.
4. Traditional bicycles (human powered) and Class-1 E-Bikes (electric assisted) both require pedal input to function. Class Two and Class Three E-Bikes are not permitted. (CVC 312.5)
5. This order is consistent with contiguous local, state, and federal park policies.
6. The District Superintendent, or his designee, may grant exemptions to this order as determined necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees, wildlife, and resources. All exemptions, except for emergency personnel,

must be obtained in writing. Requests for exemptions may be made by contacting the District Superintendent, Angeles District, 1925 Las Virgenes Road, Calabasas, CA 91302.

7. Nothing herein shall be construed in derogation of any existing provisions of law, private, contractual, residential or property rights.
8. This order shall remain in effect for one year or until further E-Bike regulations are adopted by the Department of Parks and Recreation.
